1. **Islamabad Club** (hereinafter referred to as "the Procuring Agency") invites sealed bids from eligible and qualified firms/suppliers/contractors for the **Supply, Installation & Commissioning of a New Lighting System at Badminton Courts**, including design, supply, installation, testing, and commissioning of a complete lighting system with structural support, as per technical specifications, drawings, and requirements herein.

5. **No pre-bid meeting will be held.**
6. **Site Visit:** Potential bidders may visit the site **on any working day before the bid submission deadline** between **10:00 Hrs to 16:00 Hrs**, after prior coordination with the Engineering Department.
7. All technical and contractual clarifications must be sought **in writing** via the EPADS messaging system or email to the Procurement Department.
8. **Bid Submission Method:** Bids must be submitted **electronically through the EPADS system** only. Physical submissions are not allowed.

## PART 2 – INSTRUCTIONS TO BIDDERS (ITB)

### 2.1 Eligibility Criteria

Bidders must meet the following **Mandatory Eligibility Criteria (MEC)** at bid submission:

1. **Tax Status:** Valid **NTN & Sales Tax Registration (STRN)** and appearing on **Active Taxpayer List (ATL)** of FBR.
2. **Non-Blacklisting:** Duly signed **Affidavit on Rs. 100/- Judicial Stamp Paper** declaring non-blacklisting.
3. **Experience:** Minimum **03 years** experience in electrical works/lighting installations.
4. **Similar Projects:** Completion of at least three (3) similar electrical/lighting installation projects involving high-bay or sports lighting at significant height (above 20 ft), each of value not less than PKR 2.0 million, in the last five (5) years. Completion certificates must be submitted as proof.
5. **Bid Security:** Submission of Bid Security of **PKR 100,000/-**.
6. **Product Authenticity & Supply Proof:** The bidder must provide documentary evidence demonstrating the ability to supply genuine products of the proposed brand. This may include any one of the following:
  - A valid Manufacturer Authorization Letter; OR
  - Official invoices from the last six months showing direct purchase from the manufacturer or its authorized distributor; OR
  - A Letter of Guarantee from the manufacturer or its regional authorized distributor confirming the bidder as a recognized supplier; OR
  - Proof of past successful supply and installation of the same/similar brand to reputable organizations, along with a declaration of sourcing genuine products.

### 2.2 Language & Currency

Bid documents must be in **English**. Prices in **Pakistani Rupees (PKR)**, inclusive of all taxes.

### 2.3 Bid Validity

Bids shall remain valid for **90 days** from bid opening.

### 2.4 Sealing and Marking

#### Two Envelope System:

- **Envelope-1 (Technical Proposal):** All technical, eligibility, qualification documents. **No financial information.**
- **Envelope-2 (Financial Proposal):** Only priced BOQ, Form of Bid, Price Summary, and original Bid Security.

### 2.5 Deadline for Submission

Bids must be submitted by **11:00 Hrs on July 09, 2026**. Late bids will be rejected.

### 2.6 Bid Opening

Technical bids opened first. Financial bids of only technically qualified bidders opened later on notified date.

## PART 4 – TECHNICAL SPECIFICATIONS & SCOPE OF WORK

### 4.1 Scope of Work

Complete design, supply, installation, testing, and commissioning of:

- Fabrication and fixing of MS Pipe 14 Gauge structural frame at 30 ft height
- Supply and installation of 20 nos. LED High Bay lights
- All electrical wiring, conduiting, connections, and protection devices
- Integration with existing electrical system
- Testing, commissioning, and demonstration
- **Existing lighting system to remain intact and operational as backup**

### 4.2 Technical Specifications

#### 4.2.1 Structural Frame

- **Material:** MS Pipe 14 Gauge
- **Design:** As per engineering standards for 30 ft height
- **Finish:** Hot-dip galvanized or equivalent corrosion protection
- **Mounting:** Secure fixing to existing structure
- **Safety:** Compliance with all structural safety codes

#### 4.2.2 LED Lighting System

- **Type:** LED High Bay, Philips BY698P G5 LED250 or equivalent as per approval of Client. Bidders proposing 'equivalent' brands must provide comprehensive cross-comparative data sheets against the specified benchmark (Philips) for every parameter (Lumens, Efficacy, CRI, IP, IK, Warranty, certifications). The proposed equivalent brand and model are subject to prior written approval from Islamabad Club's Engineering Department before bid evaluation. The Purchaser's decision on equivalence shall be final and binding
- The proposed LED lights must have a minimum rated life of 50,000 hours.
- **Lumen Output:** Minimum 25,000 lumens per fixture
- **Power:** Maximum 160W per fixture
- **Efficacy:** Minimum 160 lm/W
- **CCT:** 4000K or 6500K (Cool White)
- **CRI:** Minimum 80
- **IP Rating:** IP65 minimum
- **IK Rating:** IK08 minimum
- **Warranty:** Minimum 3 years on LED fixtures and drivers
- **Optics:** Wide Beam (WB) or Narrow Beam (NB) as per design
- **Certifications:** Must have PSQCA/UL/CE/IEC certifications

#### 4.2.3 Electrical Works

- **Wiring:** Copper cables, appropriate gauge for load
- **Conduits:** PVC coated metallic conduits

- **Protection:** MCBs, RCDs, surge protection as required
- **Controls:** Appropriate switching and control system

#### **4.2.4 Performance Requirements**

- **Average Illuminance:** Minimum 500 lux on playing surface
- **Uniformity:** Minimum 0.7 (Emin/Eavg)
- **UGR:** Maximum 25
- **Light Loss Factor:** Minimum 0.80

The proposed lighting design must be validated by simulation software (e.g., Dialux) and actual post-installation lux meter readings must meet these requirements. Failure to meet these performance levels during testing will be grounds for rejection of the work until rectified

#### **4.3 Special Requirements**

1. **Existing Lights:** Existing lighting system must remain intact and operational as backup.
2. **Warranty:** The bidder must submit a detailed Warranty & Maintenance Plan, including response time commitments and a process for prompt replacement of faulty units during the warranty period.
3. **Enhancement Provision:** Design should allow for future enhancement if light levels are insufficient.
4. **Installation Timing:** Major installation work to be scheduled on Sundays to minimize disruption.
5. **Completion Time:** Maximum 25 days from work order issuance.

### **PART 5 – GENERAL CONDITIONS OF CONTRACT (GCC)**

#### **5.1 Governing Law**

Governed by laws of Pakistan and PPRA Rules, 2004.

#### **5.2 Performance Security**

*The Bid Security submitted by the successful bidder shall be converted into and retained as the Performance Security until the successful completion of the Defect Liability Period. A separate Performance Guarantee for 5% of the contract value may be required as per the discretion of the Procuring Agency.*

#### **5.3 Time for Completion**

Maximum **25 calendar days** from Letter to Proceed.

#### **5.4 Liquidated Damages**

0.1% of contract price per day delay, maximum 10%.

#### **5.5 Defect Liability Period**

12 months from completion certificate.

## **5.6 Warranty**

Minimum 3 years on all LED fixtures and drivers, including free replacement of faulty units.

## **5.7 Payments**

Payment shall be released upon submission of a valid invoice by the vendor, after the successful installation, testing, and commissioning of the lights, duly verified and certified by the Club's Engineering Department, and after deduction of all applicable taxes in accordance with prevailing laws.

## **5.8 Termination**

As per PPRA rules for default, insolvency, or corrupt practices.

## **PART 6 – SPECIAL CONDITIONS OF CONTRACT (SCC)**

### **6.1 Site Location**

Badminton Courts, Islamabad Club, Murree Road, Islamabad.

### **6.2 Subletting**

The contractor is not allowed to sublet the whole or any part of this contract without the prior written consent of the Procuring Agency. Any unauthorized subletting may lead to termination of the contract and blacklisting.

### **6.3 Blacklisting & Performance**

Firms with pending/outstanding projects or a history of unsatisfactory performance with Islamabad Club may be disqualified or not considered for award

### **6.4 Existing Lighting**

Contractor shall not remove or disable existing lighting. New system must be independent with provision to use existing system as backup.

### **6.5 Working Hours**

Normal working hours: 8:00 AM to 5:00 PM. Noisy/major work only on Sundays with prior permission.

### **6.6 Safety & Cleanliness**

Contractor responsible for all safety measures, cleanliness, and damage to Club property.

### **6.7 Testing & Commissioning**

Complete testing with lux meter readings submitted. Demonstration to Badminton Sub-Committee required.

## 6.8 Product Authenticity & Warranty

The Contractor warrants that all materials supplied shall be new, genuine, of the specified brand/model, and in original manufacturer packaging. The Contractor shall provide all necessary manufacturer warranty documents and ensure warranty claims are honored regardless of the Contractor's distributor status. Islamabad Club reserves the right to verify product authenticity directly with the manufacturer and reject non-genuine products at the Contractor's cost
