Government of Pakistan, Ministry of Interior & Narcotics Control, Headquarters Anti Narcotics Force Rawalpindi invites sealed bids from eligible, registered firms for **Renovation and upgradation of Rect Cell and IT Section** in accordance with Public Procurement Regulatory Authority (PPRA) rules:
  - **Lot-1:** Fitting & Installation of cupboard, workstation, table and purchase of chairs
  - **Items:** Purchase of ACs, Touch tablets, Automatic glass sliding door, PCs, Printer, Cameras & Shredder.
2. Bidding documents are also available on PPRA EPADS portal and Anti Narcotics Force website. Tender detail is mentioned on E-Pak Acquisition & Disposal System (EPADS 2.0). Firms will download the said documents from EPADS 2.0.
3. Bidding will be conducted through EPADS 2.0 Single Stage One Envelope Procedure of Rule 36(a) of Public Procurement Rules-2004.
4. **Only firms/Contractors registered with PPRA on EPADS** as vendors are eligible to purchase bidding documents. Prices should include all applicable taxes, duties, installation and training. **Bid Money is required to be submitted in hard copy before opening of bids.**

The last date of submission is **10-07-2026 at 10:00AM**, which will be opened publicly on the same day at **10:30AM** in the presence of committee & bidders authorized representatives who wish to attend the opening session to be held at the office of President Tender Opening Committee, Headquarters Anti Narcotics Force Wavel Lines, Opposite Nur Khan Airbase, Chaklala Rawalpindi.
6. The firm providing unsubstantiated and/or incorrect information are liable to legal action and disqualification from the bidding.
7. The Authority reserves the right to reject all the applications as per PPRA Rules-2004.
8. Documents required to be submitted by the firm/ company are as under:-
  - a. Registration certificate of FBR for GST & NTN.
  - b. Certificate of sound financial position of firm with last one year bank statement.
  - c. Details of previous five years work (Experience details).
  - d. Certificate that there is no case of litigation firm/ company.
  - e. Firm should preferably be authorized dealer of mentioned categories in Pakistan.
