All bids must be submitted electronically through the E-PADS 2.0 system; no alternative submission methods will be accepted. The bids submitted via E-PADS 2.0 will be opened in **Office of the GM Engineering, PIDCL, Bahria Complex IV, 6th Floor, Ext. Block Gizri, Karachi**, in the presence of the Procurement Committee and authorized representatives of participating firms who wish to attend.

Interested Bidders can obtain any further information / clarification from office of the **Office of the concerned Manager Technical / Executive Engineer, PIDCL, Plot No.16 Carlton Hotel, near Cantt Station, Karachi, before bid submission time** Ten days prior to the deadline of Bid submission.

In case of any unforeseen situation resulting in closure of office on the date of opening or if Government declares Holiday the tenders shall be submitted / opened on the next working day at the same time & venue. Any conditional or un-accompanied of the bid security, tender will not be considered in the competition.

The procuring agency reserves the right to reject any bid, in accordance with the relevant provisions of PPRA & may cancel the bidding process at any time prior to the acceptance of bid or proposal, as stipulated in rule 33 of said rules.
