Bid security must be provided in the shape of Pay Order / CDR / Bank Guarantees (mentioning name of the Contractor's Firm and in favor of Pakistan Infrastructure Development Company Limited). In case of bogus/fake Pay Order / CDR / Bank Guarantee the bidder shall be liable to be blacklisted. Original Pay Order / CDR / Bank Guarantee for bid security and tender fee in shape of pay order shall be delivered to employer's address before the deadline submission of bid. Late delivered bid security and tender fee will lead to mark bid as non-responsive. Scanned copy of bid security and tender fee shall be attached with bid to be uploaded on EPADS 2.0.

Any Bid not accompanied by an above-mentioned instrument shall be rejected by the Employer as non-responsive. The Bid securities of unsuccessful Bidders will be returned after uploading of Bid Evaluation Report on E-PADS 2.0 / PPRA. The Bid Security of the successful Bidder will be returned when the Bidders has furnished the required Performance Security and Signed the Contract Agreement.

Bidders are required to submit their bids electronically via the E-Pak Acquisition & Disposal System (E-PADS 2.0) using the upload function. The bid submission must be accompanied by a scanned copy of the tender fee, amounting to **Rs. 5,000/-** and scanned copy of Bid Security. Furthermore, the original sealed **Tender Fee, Bid Security (Pay Order / CDR / Bank Guarantees) and E-Stamp Paper** are to be delivered in separate envelopes to the **Office of The General Manager (Engineering), Pakistan Infrastructure Development Company Limited (PIDCL), Bahria Complex IV, 6th Floor, Ext. Block Gizri, Karachi, before bid submission time.**

All bids must be submitted electronically through the E-PADS 2.0 system; no alternative submission methods will be accepted. The bids submitted via E-PADS 2.0 will be opened in the **Office of The General Manager (Engineering), Pakistan Infrastructure Development Company Limited (PIDCL), Bahria Complex IV, 6th Floor, Ext. Block Gizri, Karachi** in the presence of the Procurement Committee and authorized representatives of participating firms who wish to attend in **Office of The General Manager (Engineering), Pakistan Infrastructure Development Company Limited (PIDCL), Bahria Complex IV, 6th Floor, Ext. Block Gizri, Karachi, before bid submission time.**

The Bidders who had already executed the work/works or presently executing the work/works in PIDCL are required to obtain Performance Certificate/Certificates from relevant PIDCL Offices on prescribed Performa and upload the same along with their Bids at the date & time of Bid Submission in PIDCL Office. The bidder who has not executed the work on PIDCL should submit a Non Applicable Certificate on his letter Head on EPADS 2.0.

All other terms and Conditions are given in the bidding documents. However, interested Bidders can obtain any further information/clarification from the **Office of the concerned Manager Technical / Executive Engineer, PIDCL, Plot No.16 Carlton Hotel, near Cantt Station, Karachi, before bid submission time.**

In case of any unforeseen situation resulting in closure of office on the date of opening or if the Government declares Holiday the tenders shall be submitted / opened on the next working day at the same time & venue. Any conditional or un-accompanied of the bid security, tender will not be considered in the competition.

The procuring agency shall not be held liable for any online errors occurring during the submission or opening of bids, nor for technical issues experienced by bidders. The procuring agency reserves the right to reject any bid, in accordance with the relevant provisions of PPRA & may cancel the bidding process at any time prior to the acceptance of bid or proposal, as stipulated in rule 33 of said rules.
