Allama Iqbal Open University (AIOU), Islamabad has allocated funds for acquiring of non-consulting services including “Security Services”, planned during the financial year 2026/27.

The University now invites “Sealed Bids” through **e-Pak Acquisition & Disposal System (e-PADS)** (<https://eprocure.gov.pk>) from experienced and well-established security companies, duly registered with the taxation and relevant authorities and who are on Active Taxpayers List of the Federal Board of Revenue, for providing “Security Services” for its main campus located at Islamabad and various Regional Centres, on **Delivered Duty Paid (DDP)** basis.

The Invitation for Bids is aimed to procure services based on “Open Framework Agreement” approach. Initially, the contract(s) shall be awarded for one (01) Year and would be extended further subject to satisfactory annual performance of the Service Provider.

The bidding shall be conducted in line with “Single Stage-One Envelope” procedure of the Public Procurement Rules 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority (from time to time) and is open to all potential bidders.

Bid(s) must be accompanied by a **Bid Security** amounting to **Pak. Rs. 300,000/-**, in an acceptable form as given in the bidding document. The scanned copy of Bid Security must be uploaded through **e-PADS** and hardcopy must be submitted physically as instructed below.
