

TERMS AND CONDITIONS FOR SUPPLY OF BULK LP (LOCAL PURCHASE) OF MEDICINES / MEDICAL STORE ITEMS / ROUTINE ITEMS / DISPOSABLE ITEMS TO 134 MED BN FY – 2026 / 2027

1. All bids must be provided in soft (**USB**) and hard copies.
2. The bidder must be a Pakistani national.
3. The bidder must be income tax and professional tax payer, and has to provide the following:-
 - a. Photocopy of CNIC duly attested and drug fresh sale license
 - b. NTN Certificate of the proprietor.
 - c. GST Registration.
 - d. Sale Tax Certificate.
 - e. **Professional Tax Certificate of along with Receipt (FY 2026/2027).**
 - f. **The firms who already worked with 134 Medical Battalion in FY 2026/2027, have to provide Professional Tax Certificate (FY 2026/2027)**
 - g. Authorized Distribution Certificate.
 - h. Authority letter from the firm for authorizing the person/rep.
 - i. Specimen signature / CNIC of any person authorized by the proprietor to attend the tender opening.
 - j. A letter of acceptance of all the terms and conditions of 134 Medical Battalion for this tender.
4. Over writing on the quotation will not be accepted and incomplete quotation will be rejected on the spot.
5. Price amounts will be quoted in figures as well as in words in Pak Rupees.
6. Bills will be paid through CMA Store Sec RAWALPINDI as per Procedure in vogue.
7. The medicines supplied for the purpose must have 80% of shelf life at the time of supply and delivery time should be 45 days after issuance of supply order.

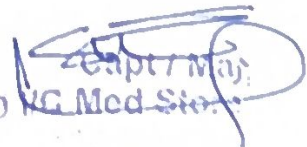

11. All packing / bottles / strips must bear "**134 Medical Battalion use only**" stamped. All medicines / surgical disposable should be out of fresh batch with long expiry date.
12. In case of any late delivery of items beyond the date specified in supply order, the concerned firm /supplier will be liable to pay fine @ 2% of total billing amount of that specific order. The final bills will be processed only after receiving penalty (if any) and in case of repeated late supplies, 134 Medical Battalion shall have the right to discontinue issuance of supply order to the concerned firm and case will be forwarded to concerned authorities for black listing of the concerned firm and supply order for that specific item / items will be given to next eligible firm.
13. The tender opening committee has the right to reject / disqualify a company / supplier as per PPRA rules.
14. An undertaking shall be provided by the supplier that if the items / medicines are declared **unfit by the laboratory or its efficacy found doubtful at any stage, the same will be replaced by the firm without any financial implications** on 134 Medical Battalion
15. Payment will be made to suppliers through Medical Officer In Charge Medical Store 134 Medical Battalion SSD WAH GARRISON.
