1. Shaheed Zulfiqar Ali Bhutto Medical University (SZABMU) Islamabad invites **Single Stage Two Envelope bids through e-Pak Acquisition & Disposal System** (E-PADS) under, PPRA Rules 2004 from the eligible bidders and well-reputed firms registered with Income Tax and Sales Tax Departments and who are on Active Tax Payer List (ATL) of Federal Board of Revenue.
2. Name of Business, Registered office, NTN, GST number and Experience.
3. Price should be in PKR.
4. **Rs200,000/- (Rupees Two Hundred thousand)** as Bid security in shape of Pay Order/CDR in favor of Shaheed Zulfiqar Ali Bhutto Medical University. The scanned copy of Bid Security must be uploaded through e-PADS and hardcopy must be submitted physically.
5. The interested firms should have a regular business office, telephone numbers, and an email address, and must provide proof of their existence in the particular business for at least three (03) years.
6. Bidding document containing detailed terms & conditions of the bidding process can be downloaded from <https://eprocure.gov.pk> free of cost.
7. SZABMU will not compromise on the quality and quantity of any item(s), and Bid security will be forfeited on supply of sub-standard items.
8. The bid(s) prepared in accordance with the instructions mentioned in the Bidding Document, must be submitted through e-PADS at <https://eprocure.gov.pk> by or **before 31-07-2026 at 11:00AM**. The bid in hard copy, along with the original bid security instrument, must be submitted in a sealed envelope clearly mentioning the name and reference number of the procurement activity. The envelope(s) should be delivered to the Purchase Office, 5th Floor, School of Dentistry, adjacent to CPSP Building, Ravi Road, G-8/3, Islamabad, on or before the due date and time.
9. The bids will be opened on **31-07-2026 at 11:30AM** through e-PADS in the presence of bidders' representatives who choose to attend the bids.

Tender clause40

The tender will be **Single Stage - two Envelops procedure** (PPRA Procurement Code 36 -b) and must be uploaded on E-PADS portal available at PPRA website, However, the vendors will drop original CDR along with copy of Tender receipt by hand in the tender Box placed at Purchase Department, 5th Floor SOD, SZABMU G-8/3, Islamabad till 1100 hrs on prescribed date announced in the Advertisement in an envelope addressed to the Registrar, SZABMU Islamabad.

Name of Work: OPERATIONS OF CAFETERIA AT SOD, SZABMU, G-8/3, ISLAMABAD, FOR A PERIOD OF 01 YEARS.

1. The bid shall comprise and uploaded through E-PADS as Technical and Financial offers.
2. Initially, only the **"TECHNICAL PROPOSAL"** downloaded from E-PADS shall be proceeded and after successful completion of evaluation of technical proposal the **"FINANCIAL PROPOSAL"** will be proceeded accordingly in accordance with the standing orders of PPRA.
3. The Procuring agency shall evaluate the technical proposal in a manner prescribed in advance without reference to the price and reject any proposal, which do not confirm to the specified requirements.
4. ***Any offer that is conditional, ambiguous or incomplete in any respect shall be rejected. No supplementary or revised offer shall be accepted after the tender opening.***
5. The technical proposal of bids shall be opened publicly at a time date and venue announced and communicated to the bidders in advance.
6. After the evaluation and approval of the technical proposals the procuring agency shall at a time within the bid validity period publicly open the financial proposal of the technically accepted bids only.
7. The bid quoted **highest** by the firm shall be accepted
8. The Vice Chancellor, Shaheed Zulfiqar Ali Bhutto Medical University (SZABMU) reserve the right to reject all bids or proposals at any time prior to the acceptance of a bid or proposal in accordance with the PPRA Rule 2004.

**TERMS AND CONDITIONS FOR OPERATIONS OF CAFETERIA AT SOD, SZABMU,
ISLAMABAD FOR A PERIOD OF 01 YEAR**

Please read the terms and conditions carefully before proceeding further.

A. General Conditions: -

1. The contract will be valid for **one (01) year** from the date of commencement (Handing over of the site); However, Contractor / Firm will continue their services at SZABMU on the same rates and terms & conditions of tender till the finalization of new contract after completion of their tenure or as per decision of SZABMU authorities regarding vacation of space.
2. Canteen will be operational at office Hours, throughout the year, however, will follow the Ramazan timings during the holy month.
3. Financial bid should be submitted in PKR and in typed form. Hand Written bids will not be accepted.
4. Bid validity is **120 days** from the date of opening the tender.
5. The approved rates will be valid for the whole contract period and there will be no increase in rates, and no escalation clause.
6. Payment of all kind of taxes & duties will be responsibility of the successful firm /Contractor.
7. On receiving letter of intent, the firm will submit 10 percent performance guarantee as well as signed contract agreement on non-judicial paper of PKR 2000/- alongwith all necessary documentation in accordance with terms and conditions within 5 days Award letter will be issued after submission of the same.
8. A Bidder is required to upload on EPADS and original is to be submitted at the time of opening of bid, a **bid security of Rs.200,000/- (Rupees two hundred thousand Only)** (the "**Bid Security**").
9. The successful firm / contractor will submit security deposit amounting of **20% of total contract amount** in shape of CDR / Pay Order or Bank Guarantee in favor of SZABMU after issuance of letter of intent and before issuance of award letter and taking over the site. The security deposit will be released after the completion of contract period subject to the NOC from authorized SZABMU officers.
10. The firm will be responsible for operations, security, management, cleanliness and compliance to the food quality standards and other regulatory requirements during the contract period for the operations of Cafeteria.
11. The Successful firm contractor will sell items of good quality and recognized

standards.

12. No General Store items i.e (Karyana) will be allowed for sale.
13. The rent will be fixed through competitive bidding for **2911 square feet area** of site for the operations of Cafeteria. The rent will commence from the date of handing / taking over of site.

The successful firm/ Contractor will be bound to pay rent by 5th of each month without any delay and original cheque / receipt will be submitted to finance section and a copy will be submitted in purchase department of the same. In case of delay payment penalty will be imposed as per penalty clause.
14. Water supply source will be provided by SZABMU however providing and installation of material required for water supply will be made available and done by contractor.
15. Electric meter will be installed by SZABMU after issuance of required NOC from SZABMU upon request of contractor and all associated charges will be borne by the contractor. Monthly bill provided by Engineering Department SZABMU will be required to be paid in accounts department and copy to be submitted to engineering department.
16. LPG cylinders will be used by contractor with sole responsibility of safety at its own expense.
17. After issuance of award letter, site will be handed over to the successful firm/contractor by the Admin department only after completion of all codal formalities and completion of all documentation required regarding Human resource etc.
18. Inventory list will be provided to successful bidder / contractor by SZABMU and same items are to be returned to the SZABMU by successful bidder / contractor without any damage at the end of contract period. Any damage to the property or theft of any item will be responsibility of contractor and will be addressed by contractor in all cases. The contractor will be responsible for the day-to-day repair/maintenance of all civil, electrical & mechanical inventories of Cafeteria and will hand over the possession of building in good condition to SZABMU on the expiry of contract period.
19. The successful firm/contractor will be responsible for suitable up-gradation / up-keep of the interior / exterior including repairing of roof, new false ceiling, Floor new furniture & fixture, and equipped in accordance with the entire satisfaction of the SZABMU.

21. No structural modification and extension beyond the existing map will be allowed in the building. Any encroachment beyond the actual Square feet measurement of site provided will be penalized and a financial penalty of Rs. 100,000/- will be imposed. which contractor will have to submit and structural modification will be restored to original immediately by SZABMU. Any cost related to damages caused by this encroachment to SOD, SZABMU property, will also be borne by the contractor.
22. The successful firm/contractor will be required to employ sufficient, competent and civilized staff to ensure quality and prompt services.
23. The contractor will be responsible for Recruitment, background verification, and police clearance for all canteen employees. Ensure security of the canteen equipment.
24. The successful firm/contractor will be responsible for proper house-keeping/ maintaining strict hygienic conditions at all time and will also be responsible for the cleanliness of the surroundings areas of the canteen premises.
25. No encroachment out of designated area will be allowed in any case. Any stand / material 1 booth etc. outside designated area will be confiscated without any notice and PKR 100,000 Fine will be imposed at the spot.
26. Expansion of business / building beyond the approved limits will not be permissible.
27. "No Smoking" signs will be prominently displayed both inside and outside the canteen by the contractor.
28. The successful firm/contractor will submit list of his employees with full address and copy of CNIC to the Security Department SZABMU.
29. Contractor will ensure that the staff employed will be medically fit, free from any communicable disease, and of sound mental health, to perform duties in a public setting. The contractor shall be fully responsible for ensuring compliance with these requirements. Any incident, health-related issue, or spread of disease resulting from the compromised health of an employee shall be the sole responsibility of the contractor, including liability for any legal proceedings arising therefrom."
30. The successful firm/contractor shall ensure security surveillance of the canteen premises.
31. Arrangements / availability of sufficient quality crockery/utensils and furniture shall be the responsibility of the successful firm/contractor. Substandard and insufficient arrangement will be liable to penalties as per list provided in eligibility criteria.
32. Any disposable item not allowed by EPA and Islamabad authorities shall not be sold on Cafeteria and all bylaws are to be followed of EPA and ICT authorities.

33. The successful firm/contractor will be required to display the approved items rate list for the Cafeteria of SZABMU at prominent places inside canteen and at payment counter at all times.
34. The successful firm/contractor will sell branded items of good quality and recognized standards only. The Contractor will only use cooking material i.e Cooking Oil & Spices of patent standard brands.
35. Selling of cigarettes/other tobacco products, un-branded & substandard food items and banned items will be strictly prohibited.
36. The successful firm/contractor will not be authorized to sublet all or part of the business/building at all. Any irregularity will be liable to termination of contract and/or confiscation of all furniture & fixture of all or a part of the business.
37. Three/Five members "**Monitoring Committee**" formulated by the Competent Authority will conduct monitoring/supervision and performance evaluation on quarterly basis to inspect the food quality. However committee can visit at any time and report any irregularity to the Vice Chancellor , SZABMU.
38. The Monitoring Committee may recommend / direct the firm/contractor for minor adjustments for improvement of services.
39. The SZABMU Authority may impose any suitable penalty including the termination of contract, as and when recommended by the Monitoring Committee or any other suitable/relevant forum/ officer.
40. If the cleanliness (hygiene, environmental cleanliness) of the premises and staff is found/reported un-satisfactory and selling of substandard & poor branded food at any time, the firm/contractor will be fined Rs. 1000/-. On second complaint, a fine of Rs.5000/- will be imposed and on third complaint, the contract may be terminated as per decision of authority.
41. If the firm/contractor failed to improve his attitude and services despite multiple complaints and penalties for three successive notices, the Competent Authority reserve the right to terminate the contract after serving a final notice.
42. In case of damage to the institute property by the contractor or his employees, the necessary repair will be carried out at the risk and cost of the contractor with information and consent of the Civil Engineering department of SZABMU.
43. In case of non-depositing of monthly bills by 5th of every month Rent, a penalty of PKR 15,000/- (fifteen thousand per/day) of total amount payable will be charged from 6th day of relevant month till the dues are cleared. All services will be disconnected

automatically if non-payment is not addressed for 2 consecutive months.

44. Water charges of Rs 5000 per month will be paid by the contractor in Accounts department before 5th of every month.
45. If the contractor is found selling cigarettes, tobacco products or banned items, a fine of Rs.5,000/- will be imposed on first offence and in case of any subsequent offence will result in termination of contract without notice.
46. However, in case of termination of Contract Agreement, the SZABMU Administration will serve 60 days advance notice to the Contractor. In case the contractor decides to discontinue the contract, then the Contractor will also be responsible to give **60 days advance notice** to the SZABMU Authority for termination of premature contract.
47. In case of any dispute, the decision of the SZABMU will be final and will not be challengeable at any forum or Court of Law.
48. If an arbitrator is required, Procuring Agency will act as an arbitrator and the arbitrator's decision will be binding/final and not challengeable at any forum or court of law

- vii. Undertaking by the firm on Stamp paper not less than Rs. 100/- that the firm is not blacklisted/ penalized by any Government Departments or private organizations.

NOTE:

The bidder shall fill this checklist carefully & attach the relevant documents in the same sequence as prescribed. The said criteria will determine the eligibility of bidders, failing which the firm/bidder will be disqualified.

The firm/bidder that will provide or it be proven that incorrect/ false information/ document has been provided is liable to be disqualified & blacklisted from SOD, SZABMU.
