Single Stage-One Envelope Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting Least Cost Based Selection (LCBS) Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
4. All Bids must be accompanied by a Bid Security amounting to **Rs.100,000/- (one hundred thousand only)** described in Bid Security Section in Bidding Document in the form of Pay Order, Banker's Cheque and Demand Draft on the prescribed format in the name of **Chief Executive officer FESCO**.
