5. If tender of a contractor not enlisted with MES is accepted he shall be required to deposit **Rs. 300,000/-** as security in the form as demanded by the accepting officer.
6. The earnest money shall be refunded to the contractor if his tender is not accepted and after he has returned all the documents issued to him. In case of acceptance of tender, the earnest money deposited by the contractor shall be adjusted as part of security to be deposited
