Sealed Bids are invited by the Divisional Superintendent, Pakistan Railways, Peshawar from the Government registered Contractors/Firms having experience of Tax collection and upto date renewal of their registration with the FBR / concerned department for the **COLLECTION OF TOLL TAX ON KALABAGH RAIL-CUM-ROAD BRIDGE NO. 03 ON MARI INDUS - BANNU SECTION** for a period of one year.

2. Tender documents can be obtained from <https://vendors.epads.gov.pk/> Bidders must submit price bid through E-Pak Acquisition & Disposal System (EPADS v2.0). Price Bid must be accompanied by a scanned copy of Bid Security an amount of Rs. 430000/- in the form of CDR, in the name of Divisional Accounts Officer, Pakistan Railways Peshawar. Whereas, bid security an amount of Rs. 430000/- in original shall be submitted in the office of Divisional Superintendent, Pakistan Railways Peshawar (**Works Accounts Branch**) alongwith other necessary documents. Name of firm / agency on CDR is mandatory. Tender must be uploaded on E-PADS v2.0 at 11:00 hours or before, on 17 Aug, 2026.

3. Only bids through EPAD v2.0 will be entertained and no other bid will be accepted except EPAD. Price bid will be opened on same date in the chamber of Divisional Accounts Officer, Pakistan Railways, Peshawar at 11:30 hours in the presence of the representatives of the firms who want to be witness.
