GENERAL TERMS AND CONDITIONS

1	<u>SINGLE STAGE –TWO ENVELOPES PROCEDURE (PPR-2004)</u> i) The bid shall comprise one single package (duly sealed) containing two separate Envelope. Each envelope shall contain separately financial proposal and the technical proposal (duly sealed). ii) The envelopes shall be marked as “FINANCIAL PROPOSAL” and “TECHNICAL PROPOSAL” in bold and legible letters to avoid confusion. iii) Initially only the envelope marked “TECHNICAL PROPOSAL” shall be opened. iv) The envelope marked as “FINANCIAL PROPOSAL” shall be retained in the custody of W.M (D) Office without being opened. v) W.M (D) shall evaluate the technical proposal as per evaluation criteria given in this tender without reference to the price and reject any proposal which do not conform to specified requirements. During the technical evaluation no amendments in the technical proposal shall be permitted. vi) The financial proposal of the bids shall be opened publicly at a time, date and venue announced and communicated to the bidders in advance. After the evaluation and approval of technical proposal, the Works Manager/Diesel, C.D.L.Workshop, Rawalpindi (Procuring Agency) shall at a time within bid validity period, publicly opened the financial proposal of the technically accepted bids only. The financial proposal of bids founds technically non-responsive shall be returned unopened to the respective bidders and the bid found to be the lowest evaluated bid shall be accepted.
2	<u>REJECTION OF BIDS</u> i) The Works Manager/Diesel, C.D.L.Workshop, Rawalpindi. (Procuring Agency) may reject all bids or proposals at any time prior to the acceptance of a bid or proposal. The grounds for rejection of all bids or proposals (but procuring agency is not required to justify these grounds), may be communicated to a bidder upon written request. The procuring agency shall incur no liability, solely by virtue of its invoking sub rule (i) towards suppliers or contractors who have submitted bids or proposals.
3	<u>BID VALIDITY.</u> Bidders may note that only one rate and one place of delivery should be quoted against an item in the tender with a validity period of not less than Sixty (60) days, with the exception of non-ferrous metals where the validity less than Sixty (60) days, may also be quoted by the bidders. In case of non observance of any of these provisions, offer will be ignored straightway without making any back reference.
4	<u>DELIVERY PERIOD / SCHEDULE</u> Bidder are required not to quote delivery period more than 45 days from date of issuance.

7	<u>BID SECURITY</u> 2% Earnest money of the Total Value in shape of Call Deposited Receipt (CDR) in the name of Divisional Accounts Officer, Rawalpindi is Compulsory along with the offer and is to be attached with “TECHNICAL BID”. Banker’s Cheque, pay order or any other Cheque will not be accepted, failing to which offer will be ignored/rejected straightway.
8	Bidders are requested to strictly abide by the delivery period mentioned in the purchase order as this form the essence of the contract. If the firm fails to supply the material by stipulated date, terms and conditions of the contract (under which all rights are reserved) will be enforced without any correspondence and without prejudice.
9	Bids with alternate offer against an item shall be ignored/ rejected straightway. Firms approved by DSM/CME/Locos Office for this item will only be declared technically responsive as the item is of critical nature. All other offers/bids will be declared technically un-responsive.
10	Bidders will certify that cost of the goods/ services given in the offer is realistic, calculated and based on current market price, failing which the offer will be ignored.
