INVITATION OF BIDS THROUGH E-PADS

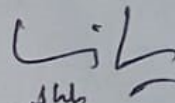
Divisional Superintendent, Pakistan Railways, Quetta, invites sealed bids for execution of below works based on Pakistan Railways Composite Schedule of Rates 2016, & through rates on the basis **Single Stage-Single Envelop** from the eligible bidders/Firms having fresh renewal of license i.e CE-06 with Pakistan Engineering Council and specialization codes in CE-10 category, registered/cleared from Sales & Income Tax Department and active on ATL of FBR.

Bidding /Tender Documents can be obtained from <http://pa.epads.gov.pk> (**Bid/Tender No. P-78193**), (**New Version 2.0**) free of cost. Bidder must submit their bids **through E-Pak Acquisition & Disposal System Version 2.0 (E-PADS)**. Bid/Tender must be accomplished with scanned copy of Bid Security (Name of firm/Agency on call deposit is mandatory) in the form of CDR/Pay order, in the name of **DAO/P.R Quetta**. Whereas, bid security in original along with hard copy of bidding documents shall be submitted in the office of the **Divisional Engineer-II, P.R, Quetta, (Work Accounts Branch)**. Along with other necessary documents as stated in bidding documents. Bid/Tender must be up-loaded on E-Pads at 12.00 hours on 24th August/2026.

Only bids through E-Pads will be entertained and no other bid will be accepted except E-Pads, Bids will be opened on same date at 12.30 hrs in the office of **Divisional Accounts Officer, P.R, Quetta** in the presence of representatives of the firms who want to be witnessed. The Railway administration reserves the right to reject all the bids at any time prior to the acceptance in accordance with PPRA Rules.
