WAPDA Hospital, Mangla invites to prequalify local chemists/ Pharmacies for invitation to bids(s), and sign the framework agreement with the selected bidders subsequent to bidding process for supply of local purchase medicines on Green Slips on daily basis for Financial Year 2026-27.

1. Online bid submission through EPADS required from CHEMIST / PHARMACIES holding valid Drug Sale License registered with FBR and EPADS having active NTN and STN for supply of medicines.
2. Contract will be valid for 01 Year, and extendable for one year with mutual consent and satisfactory performance.
3. The objective of the intended closed Framework agreement is the on-demand supply of medicines on daily basis for entitled patients through green slip at WAPDA Hospital Mangla with successful bidders, and the purposes of this Prequalification Notice is to provide the very basic information to enable the potential applicants to decide whether or not to respond to this Prequalification Notice.
4. Bid must be accompanied by an undertaking on stamp paper that the bidders has not been black listed by Government, Semi Government and Private Organization.
5. Prequalification process is open for all Local Applicants subject to fulfilling the eligibility requirements mentioned in the respective Prequalification Documents. Interested Applicants may obtain further information form WAPDA Hospital Mangla.
