- National Highway Authority (NHA) invites e-bids from the prospective bidders:
 - Having NTN Certificate as Active Tax Payer List with FBR.
 - Bidding is open to all prospective bidders having valid license of Pakistan Engineering Council (PEC) as per following requirements in line with financial limits fixed by PEC:

- Having no shortfall of NHA revenue and have not been declared defaulters, debarred or blacklisted by any government agency.

Financial e-bids of only technically qualified bidders will be opened later on.
- Bid Security in original must reach at NHA HQ on **26th August, 2026** by **1130 Hours** as a mandatory requirement.
- All prospective bidders shall provide following undertaking in original at the time of Technical e-Bid opening as mandatory requirement on a stamp paper of Rs. 100/- duly attested by **Notary Public / Oath Commissioner** stating that:

- a) He/his company/firm/sole proprietor is not blacklisted and he is not declared defaulter of any Govt. Department.
 - b) They have gone through all Bidding documents/Request for Proposal (RFP).
 - c) The information/record given in/with the bid is correct and they have not concealed any relevant information.
