04. All contractors will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.								
05. Contractors from approved list of MES in Category 'E' and also having experience of this type of work may only apply.								
06. Contractors who desire may be present at the time of opening of tenders.								
07. The accepting officer reserves the right to accept or reject the tenders. Reject tenders will be dealt with as per Para-33 (i) of PPRA Rules.
