Cantonment Board Gujranwala (CBG) invites / requests Proposals under rule 36 (a) of PPRA Rules, 2004 i.e. (Single stage-one envelope procedure-each, from authorized well reputed firms / suppliers registered, for Supply / Fixing of CNC Sheet Box ('8x4') with 4 Side Opening Gate (Iron Pipe Frame & Sheet 18 Swg around electric poles at Muhammad Hussain Road.
 1. All bids must be accompanied by a call deposit receipt (CDR) of two percent (2%) in the name of "Cantonment Executive Officer, Gujranwala for the value of the quoted price which will be refunded once the bidding process has been completed and contract awarded to the successful tenderer.
 2. The Purchaser will not be responsible for any costs or expenses incurred by bidders in connection with the preparation or delivery of bids.
 3. Only firm / suppliers / manufactures registered with PPRA on E-PADS as vendors are eligible through online E-PADS Tendering. The bidders shall complete and authenticate their complete E-Bids (by uploading PDF file) and it must be submitted online on e-procurement system (EPADS) website i.e. <https://epads.gov.pk> and www.ppra.org.pk

The prospective bidders are required to submit Bids Security / Earnest Money (CDR) amounting to as above mentioned against work in favour of Cantonment Board Officer, Cantonment Board Gujranwala, CDR must be issued from any schedule bank against firm's account. Name of firm should be clearly mentioned on instrument (Call deposit / CDR). The Prospective bidders shall be submitted three (03 days) before opening of Bids & Pay order is not acceptable.
