

REQUEST FOR BIDS

PROCUREMENT OF CIVIL WORKS

1. The **Allama Iqbal Open University, Islamabad Pakistan (Islamabad) (Directorate of Works)** has reserved Funds for the procurement planned for FY **2026-27**. The **Allama Iqbal Open University, Islamabad Pakistan (Islamabad) (Directorate of Works)** intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "**Roof Treatment of Various Blocks at Main Campus, Islamabad**" with the reference of "**P96193**".

2. The **Allama Iqbal Open University, Islamabad Pakistan (Islamabad) (Directorate of Works)** invites sealed Bids from eligible Bidders for procurement of Works (**Roof Treatment of Various Blocks at Main Campus, Islamabad**) described in the bidding documents on **EPADS v2.0**.

3. **Single Stage-One Envelope** will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, Regulatory Guides, Procurement Guidelines or Instructions issued by the Authority from time to time.

4. All Bids must be accompanied by a Bid Security amount described in Bid Security Section in Bidding Document in the form of **Pay Order, Call at Deposit**. Or all bids must be accompanied by bid securing declaration in the format specified in the Bidding documents

5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at **<https://epads.gov.pk/opportunities/federal/procurements/96193>** for all the interested bidders registered on **EPADS v2.0**. Bidders are required to get themselves registered on **EPADS v2.0** to participate in Bidding process.

6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Thursday, September 24, 2026 10:30 AM**. E-bids will be opened by using **EPADS**

v2.0 on the same day at **Thursday, September 24, 2026 11:00 AM**. Manual submission of Bids shall not be entertained. Those vendor who have not yet registered on the new version of **EPADS v2.0**, may register themselves on <https://vendors.epads.gov.pk/>.
