### PROCUREMENT OF NON-CONSULTANCY SERVICES

#### PROVISION OF LIGHT TOWER ON RENTAL BASIS FOR CRICKET STADIUMS FOR THE PERIOD OF ONE YEAR STARTING SEPTEMBER 2026 TO AUGUST 2027

1. The Pakistan Cricket Board (Pakistan Cricket Board (PCB)) has reserved Funds for the procurement planned for FY 2026-27. The Pakistan Cricket Board (Pakistan Cricket Board (PCB)) intends to apply part of the proceeds of this Fund to cover eligible payments under the contract for the "PROVISION OF LIGHT TOWER ON RENTAL BASIS FOR CRICKET STADIUMS FOR THE PERIOD OF ONE YEAR STARTING SEPTEMBER 2026 TO AUGUST 2027" with the reference of "P106030"
2. The Pakistan Cricket Board (Pakistan Cricket Board (PCB)) invites Bids through EPADS v2.0 from eligible Bidders registered on EPADS v2.0 for provision of Non-Consultancy Services.
3. **Single Stage-One Envelope** Procedure of Principal Method of Procurement (i.e. Open Competitive Bidding) will be used by adopting **Least Cost Based Selection (LCBS)** Technique for the subject procurement, in line with the Public Procurement Rules, 2004 and any Regulations, and Instructions issued by the Authority (from time to time).
4. All Bids must be accompanied by a Bid Security described in Bid Security Section in Bidding Document in the form of **Pay Order, Call at Deposit, Demand Draft** or Bid Securing Declaration on the prescribed format described.
5. E-Bidding documents, containing detailed terms & conditions, specifications and requirements etc. are available on **e-Pak Acquisition and Disposal System (EPADS)** at <https://epads.gov.pk/opportunities/federal/procurements/106030>.
6. The e-bids, prepared in accordance with the instructions in the e-Bidding documents, must be submitted through **EPADS v2.0** on or before **Monday, September 21, 2026 11:00 AM**. E-bids will be opened on the same day at **Monday, September 21, 2026 11:30 AM**. Manual submission of Bids shall not be entertained.
