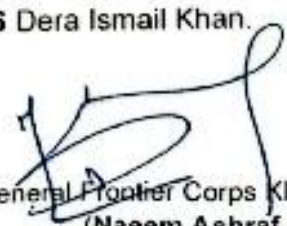

3. **Technical/ financial bids** alongwith samples must be reached Ordnance Branch Headquarters Frontier Corps KP (south) Dera Ismail Khan before 1000 AM on **22 Sep 2026**.
4. Technical/ financial bids will be accepted on depositing of the required samples.
5. Desirous firms/ contractors shall be registered with income tax department and on Active Taxpayers List with Federal Board of Revenue Pakistan.
6. Tender documents, containing detail terms and conditions and technical specification can be obtained from Ordnance Branch Headquarter Frontier Corps KP (South) Dera Ismail Khan.
7. Technical/ financial bids will be opened in the presence of bd members on **22 Sep 2026** according to the PPRA rule 2004.
8. The bids shall comprise a single package containing two separate envelopes. Each envelop shall contain separately the financial proposal and technical proposal. The envelopes shall be marked as "**FINANCIAL PROPOSAL**" and "**TECHNICAL PROPOSAL**" in bold and legible letters to avoid confusion.
9. No Financial/ Technical bids will be accepted after due date and time.
10. Samples/ Supplied stores will be tested from recognized laboratory and charges will be paid by concerned firms.
11. Preferably manufactures or their representatives to participate along with the firm's authority letter and same shall be submitted with tender documents.
12. Samples deposited in the previous tenders will not be accepted for this tender.
13. Firm will deposit affidavit clearly mentioning "**NON-BLACKLISTED FIRM**" from any Official/ Government/ Semi Government Organization.
14. Firm or the Owner will deposit NTN Certificate, Affidavit to assess the financial health of the firm, last year tax return certificate duly vetted from FBR, Bank statement of last six months and copy of Owner CNIC.
