1. Applications are invited by the **GE (NAVY) TURBAT at PNS SIDDIQ, Pasni Road Turbat** for pre-qualification of contractors/firms and issue to tender against the following works under GE (Navy) TURBAT in the light of Clause 13,15 &16 of PPRA Rules 2004.

The applications shall be scrutinized and the tender documents will only be issue to the firms who have sufficient experience in the relevant field and satisfy other special conditions required for the job and area. Tenders will be issued to the scrutinized contractors. The tender must be received in the accepting office by 1130 Hrs on **21 SEP 2026** and will be opened at 1200 HRs on the same date.

Note: Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the Court of Law and that no special report of Directorate of Inspection and Evaluation (E-in-C's Branch GHQ) is outstanding against them.

3. All contractors, irrespective of their enlistment or non-enlistment with MES will certify in writing that they are registered with Pakistan Engineering Council (PEC) and will submit a copy of their registration. Contractors not registered with PEC are ineligible to apply.

4. Contractors borne on approved list of MES in category 'A', 'B', 'C' & 'D' having experience of this type of work may only apply.

5. Contractors who desire may be present at the time of opening of tenders.

6. The accepting officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per Para 33 (i) of PPRA rules.

7. The interested parties can contact GE (N) Turbat at PNS SIDDIQ / authorized representatives for further details from 0800 to 1400 hours on all working days.
