Firms, un-registered / un-indexed with DGDP interested to participate in the competition on Earnest Money are required to provide financial capability (minimum 06 months Bank Statements) proof of go down and manufacturer / stockiest, 02 photocopies of NIC of the owner in case of FOR tenders and agency agreement with OEM along with the request. Request for issuance of IT will be entertained 07 days before opening date of tender.

4. A treasury Challan of Rs. 2,000/- debatable to Main Head XLVII Main Head XII Sub Head A is required to be submitted by the un-registered / un-indexed firms along with the request.

5. Tender Notice is also available on PPRA website i.e. www.ppra.org.pk.

6. Firm past performance based on their previous defaulted contracts, late deliveries / late submission of BGs will be considered as essential bench mark in acceptance or rejection of quotations.

(Note) The firm will have to provide (NDA) to Directorate of Procurement (Air) on judicial stamp paper of Rs. 100/- prior issuance of tender documents.
