### E-AUCTION OF SCRAP MATERIAL LOTS

- Karachi Port Trust invites electronic bids for e-Auction of scrap material on “as is-where is basis”.
- The bidders must be registered with Federal Board of Revenue (FBR) for Income Tax and Sales Tax and must be on Active Taxpayer List.
- E-bidding documents as per Disposal of Public Assets Regulations, 2026, containing detailed terms and conditions, specifications and requirements etc. are available for the registered bidders on **EPADS Version 2.0** at <https://epads.gov.pk/>
- The electronic bids, must be submitted by using **EPADS (2.0 version)** on or before. **Thursday, September 17, 2026 at 11:00 AM.** Manual bids, shall not be accepted.
- Electronic bids will be opened on the same day. i.e **Thursday, September 17, 2026 at 11:30 AM.**
- Interested bidders are advised to inspect the lots during office hours at central disposal yard, west wharf road Karachi, before submission of bids.
- The participants must submit an attested copy of their valid CNIC through EPADS.

#### IMPORTANT NOTES

1. Bidders are responsible to complete all the formalities/ requirements for submission of electronic bids.
2. Bidders should read the complete terms and conditions/ specifications in bidding documents available on EPADS v2.0.
3. All taxes, levies duties and other charges applicable will be charged as per Government rules.
4. All lots will be sold to the highest bidder after approval of the Competent Authority.
5. The decision of the Competent Authority shall be final and binding.
6. In case of any discrepancy or technical issue, EPADS helpdesk may be contacted.
7. KPT may reject all bids or proposals at any time prior to the acceptance of a bid or proposal.
8. The bidder must furnish refundable earnest money equal to 10% of the reserve price for each lot.

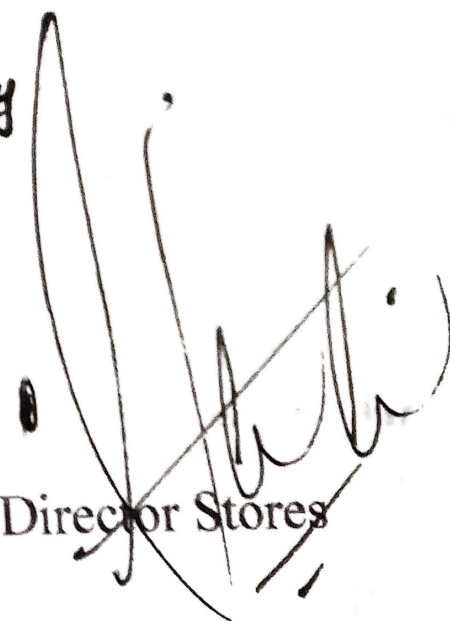
