Tender will be opened at **1130** hours on **07-10-2026** (Wednesday) and must reach POF Bids Centre through Air mail / courier before 1100 hrs. The tender received late will not be entertained. The bids "By hand" must be received in the Bid center 30 minutes before the time of Bid opening. You may witness the opening of the tender if so desired. If a representative is deputed, he should bring a **letter of authority**. The venue of Tender Opening is **POFs Bid Centre (Room No. 02), Behind Rabta Hall, POF, Wah Cantt.**

1. SUBMISSION OF TENDER

1.1 Please quote as per following single stage two envelope method. You are required to quote in two parts: -

A. Part I "Technical Offer":

- i. It should exclusively give technical details and literatures/brochures of the offered items; validity date; delivery schedule; and signed undertaking given on the schedule to this Tender Enquiry. It must not indicate price, costs etc. Bid Money of **Rs. 70,000/-** should accompany in the shape of **Pay Order** with Technical offer.
Tenders received without Bid Money will be rejected.
- ii. In case the offer is submitted thorough a Local agent / firm is involved in the submission of bid. Local agent / firm must invariably be accompanied by tender fee @ **Rs. 2500/-** and bid money amount to **Rs. 70,000/-** in shape of pay order. **Failing which offer will be rejected.**

Note: it must not indicate price, costs etc.

B. Part II "Commercial Offer": It should indicate the commercial terms e.g. price, terms of payment, mode of payment, mode of supply. Each part should be placed in a separate sealed cover. The envelopes should be inscribed with: Part I "Technical Quotation without Price" and Part II "Commercial Quotation with Price".

2.0 **GENERAL INSTRUCTIONS:**

- 2.1 The quotation must remain valid for at least **90 days** from the date of opening of tenders.
- 2.2 The quotation should hold good for any reduced or enhanced quantity without notice.
- 2.3 The Quotation Should be valid for all quoted items, irrespective of whether contract is awarded for only those items that are technically qualified and lowest in rates.
- 2.4 In the event of non-acceptance of offer, no intimation will be given to the tenderer.
- 2.5 Conditional offers or alternative offers are likely to be ignored.
- 2.6 Quotations should be based on "Free Delivery" at Wah Brass Mill Quaid Avenue, (Adjacent to POF Main Gate), Wah Cantt.
- 2.7 The suppliers registered with Sales Tax Dept. are only eligible to participate in the T.E. The competitive supplier shall have to furnish Sales Tax Invoice and Professional Tax Clearance Certificate.

3.0 **TENDER FEE:**

4.0 **BID MONEY:**

- 4.3 Bid Money of successful tenderers will be retained until the contract is finalized. Bid Money will be forfeited and firm will be blacklisted in case the quotation is withdrawn before the expiry of its validity date in accordance with Rule 19 of PPRA.
- 4.4 State owned organizations are not required to provide Bid Money.

5.0 **PERFORMANCE GUARANTEE:**

- 5.1 The successful bidder will provide **Performance Guarantee at the rate of 10% of the contract value in favour of Wah Industries Ltd, Wah Cantt.** The Performance Guarantee will be furnished in the form of Pay Order from any scheduled bank. The Performance Guarantee will be submitted prior to the placement of Contract and the same will be returned on satisfactory completion of the contract. In case the firm fails to supply the contracted store / contractual obligations in full or in part, PG will be forfeited.

- 6.2 Firms must ensure that the quoted items are of good quality and as per specifications.
- 6.3 Submitted accepted samples of technically qualified and commercially lowest firm shall be adjusted against the bulk quantity to be supplied under the contract.

7.0 **INSPECTION:**

- 7.1 Supplies shall be subject to the Inspection at Purchaser's premises.
 - a) Inspection Authority = CTO-WIL or his authorized rep.
 - b) Inspection Agency = Q.C. WBM, Manager-QC-WBM
 - c) Place of Inspection = WBM, Wah Cantt
- 7.2 Rejected Store will be removed and replaced with the acceptable stores by the supplier at his own expense, within a specified time.

8.0 **ACCEPTANCE OF OFFERS:**

The Right to accept or reject any offer in full or in part, without assigning any reason is hereby reserved.

9.0 **FAILURE TO SUPPLY THE STORES:**

Performance Guarantee @ 10% of the total value of contract will be submitted prior to the placement of contract. The Performance Guarantee will be returned on satisfactory completion of the contract. In case of failure of the supply, the Performance Guarantee will be forfeited.

10.0 **MATERIAL / STORES:**

The material / stores shall conform to the specifications as laid down in the schedule to Tender Enquiry.

11.0 **WARRANTY / GUARANTEE:**

The stores shall be supplied on Warranty / Guarantee subject to Inspection at WBM. Rejected stores will be removed and replaced with the acceptable store by the supplier at his own expenses within specified time.

12.0 **PAYMENT:**

- i) 100 % Payment after receipt and acceptance of stores at WBM, Wah Cantt.
- ii) Partial Supply / Partial Payment is allowed.

14.0 **LIQUIDATED DAMAGES:**

If the supplier fails to supply the contracted store in-accordance with the delivery schedule as specified on contract, liquidated damages at the rate of 2 % per month or part of the month of the value of the late delivered stores may be levied, but the total damages shall not exceed 10 % of the contract value. However, if the delay occurs due to force majeure or such other circumstances which the purchaser may consider unavoidable the purchaser may extend the delivery period.

15.0 **TERMINATION OF CONTRACT:**

If at any time during the currency of this contract, the purchaser decides to terminate the contract for any reason whatsoever (other than for reasons of FAILURE TO SUPPLY THE STORES) he shall have the right to do so.

16.0 **SECURITY OF INFORMATION:**

The tenderer and his employees must not communicate any information relating to the sale / purchase of materials under this enquiry to any person other than the manufacturer or to any press or agent not authorized in writing by Wah Industries Limited (WBM) to receive it.
