- iv. Bid Security must be enclosed in a separate sealed envelope along with tender, with name of work clearly mentioned on the envelope.
- v. Two copies of BOQ shall be submitted by bidder (one original & 2nd photocopy) and both shall be sealed, pre-signed and stamped and name of work shall be clearly mentioned on the envelope.
- vi. Rates shall be written in figures and words in separate columns. In case of conflict in figures and words, the rate quoted in words shall prevail.
- vii. Competent authority may reject any or all bids/ proposals at any time prior to acceptance of bid or proposal.
- viii. Tender will not be issued or accepted by Post/ Courier/ Telegraphic means.
- ix. Tender Evaluation Committee reserves the right to demand the analysis of quoted rates to check their reasonability and workability.
