Note:- Contractors shall provide certificate that they are not involved in any type of litigation with Government Department in the court of law and that no special report of Directorate of Inspection and Evaluation (E-in-C' Branch GHQ) is outstanding against them.

3. Firms will furnish list of personal, bank statement, NTN certificate. Income tax return for the last three years.
4. Only those firms / contractors can apply who fulfill the under mentioned criteria:-
 - a. Enlisted with PEC in Cat E & above in the relevant field with validity at least up to Jun 2027.
 - b. Preferably enlisted with MES in Cat A in case of non-enlisted firms. 2% bid security money be provided (Refundable).
 - c. no special report of DI&E and no outstanding DI&E recoveries .
5. Tender will be issued to pre-qualified firms/ contractors by MES Allama Iqbal Gar at 1130 hours on 30 Sep 2026 and will be opened on the same day at 1200 hours.
6. Bidding documents:-
 - a. Procuring agencies shall formulate precise and unambiguous bidding documents that shall be made available to the bidders immediately after the publication of the invitation to bid
 - b. The procuring agency shall provided a set of bidding documents to any supplier or contractor on request and subject to payment of price, if any

Explanation:- For the purpose of the Sub-Rule price means the cost of printing and providing the documents only
7. Incomplete applications shall not be entertained.
8. The Accepting Officer reserves the right to accept or reject the tender. Rejected tenders will be dealt with as per para 33 (1) of PPRA Rules.
