5. The earnest money at the rate of 2% of the total quoted value in the shape of CDR/(Pay Order (Cheque not acceptable) in the name of Head, LAO, PINUM, P.O Box No. 2019, Jail Road, Faisalabad must accompany the offer, failing which the offer is liable to be rejected.
6. Advance payment shall not be possible.
7. Conditional/telegraphic offers will not be entertained.
8. Quotation must be sent in closed/sealed envelope. Envelope should be marked with tender No. and date of opening.
9. Delivery period must be mentioned specifically in term of days.
