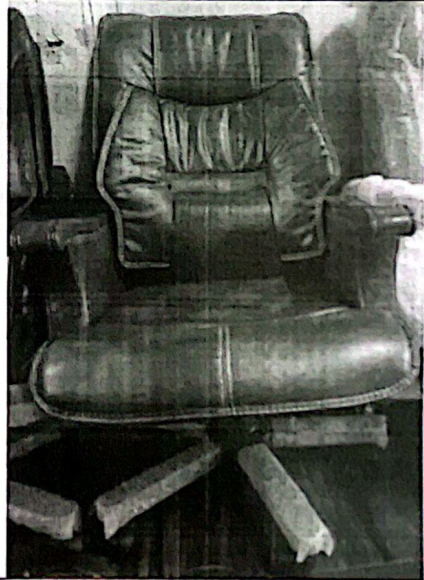

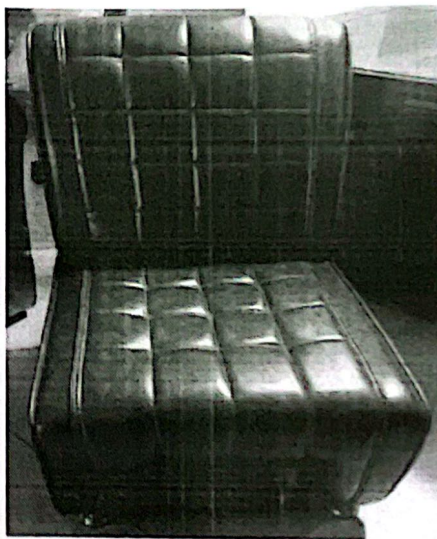

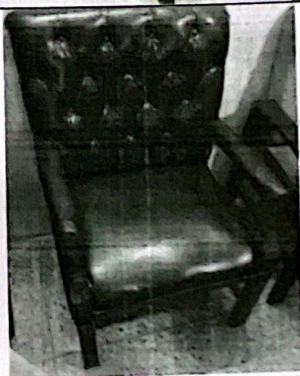

2. No bid will be accepted without earnest money/CDR which is 02%.
3. Bid will not be accepted if a vender is under litigation with State Life or blacklisted by any of Provincial or Federal Government Department, Agency, Organization or autonomous body or Private Sector Organization anywhere in Pakistan. Personal influence will also disqualify bidders.
4. Bidding documents for each item, containing detail terms and conditions etc... are available and can be downloaded from **State Life Insurance Corporation of Pakistan (SLIC)** website www.statelife.com.pk as well as from EPADS-PPRA website www.eprocure.gov.pk against Cash as Tender Fee Rs.2000/- before the bid opening through company letter head (Non Refundable).
5. All the bids must include G.S.T. and all other applicable taxes.
6. The Bids Prices shall be lowest quoted on **Item wise**.
7. All Submitted bids must be duly signed and stamped.
8. The selected firms will provide items within 30 days from receipt of supply orders as per sample to be approved by SLIC. If supply is not made in due time, a fine of 0.5% of contract value per delayed day will be charged to the firm. If supply/ installation are delayed beyond 30 days from receipt of supply order, the earnest money will be confiscated.
9. The approved bidder immediately after receipt of Work Order shall provide a sample of the Item to SLIC for scrutiny and approval. After the sample is approved, the bidder shall supply/ install rest of the items as per approved sample.
10. SLIC can increase or decrease the quantity of items to be purchased and also reserve the right to accept or reject any or all tenders/Bids in line with PPRA rules.
