TERMS & CONDITIONS

- Availability of Documents:**
The bidding documents shall be available exclusively on the PPRA and E-PADS V2.0 portals, and no hard copies shall be issued. Only firms duly registered as vendors on E-PADS V2.0 shall be eligible to participate in the bidding process. Prospective bidders shall quote their rates as a percentage above or below the applicable rates prescribed in the MES Schedule of Rates, 2025.
- Submission & Opening of Bids:**
 - E-bids, prepared in accordance with the instructions contained in the bidding documents, must be submitted electronically through E-PADS V2.0 on or before 14-10-2026 at 1:00 PM.
 - The bids will be opened on the same day at 1:30 PM.
 - Manual submission of bids shall not be entertained. Vendors not registered on E-PADS V2.0 may register at: <https://vendors.epads.gov.pk/>. Tutorial link: <https://www.youtube.com/watch?v=MNW6T38v7tc>.
- Grievance Redressal:**
In accordance with Rule 48 of PPRA Rules, 2004, a Grievance Redressal Committee (GRC) has been constituted. The notification is available on the Procuring Agency's website and E-PADS portal.
- Procurement Method:**
Procurement shall be carried out through Open Competitive Bidding under Single Stage - One Envelope Procedure, PPRA Rule 36(a), adopting the Least Cost Based Selection (LCBS) technique in line with PPRA Rules, 2004.
- Earnest Money:**
Bidders shall submit 2% of the estimated cost in the shape of Call Deposit Receipt (CDR), issued by any scheduled bank in favor of the Cantonment Executive Officer, Bahawalpur Cantonment Board.
 - A scanned copy shall be uploaded with the e-bid.
 - The original CDR must be submitted 03 days prior to opening of bids.
- Award of Contract:**
Issuance of work order shall be subject to the approval of the Competent Authority.
- Eligibility:**
Firms/contractors blacklisted by any Government/Semi-Government organization shall not be eligible to participate.
- Additional Terms:**
All quality-assurance tests required for the works shall be conducted through reputed laboratories, and the entire cost of such testing shall be borne by the successful bidder. Detailed terms and conditions may be obtained from the office of the Bahawalpur Cantonment Board during office hours on any working day.
- Right of Rejection:**
The Procuring Agency reserves the right to accept or reject any or all bids prior to acceptance in accordance with Rule 33(1) of PPRA Rules, 2004, without assigning any reason.
